


### Heidi McClintock Sub-District 2

## **Certification of Irrigated Acres**

Certifying irrigated acres is part of the updated Groundwater Management Plan Rules and Regulations (Chapter 12) that was adopted by the Board of Directors on March 27, 2014. The acres certified were those acres irrigated by groundwater and surface water during the 2016 crop year. These acres will serve as the baseline data. Recently, certified producers received a mailing from the NRD, showing certified acres on record as well as requesting some supplemental information such as crop type, irrigation method and tillage practices. Please carefully review the acreage listed and notify the NRD of any changes. If no changes are required, please fill out the supplemental information and return the forms to us. Irrigators will only need to notify the NRD in the future if any changes are made. Changes are due by March 1st of each year. By knowing the location and number of irrigated acres, the NRD will be able to better protect current irrigators existing irrigation rights. Additional groundwater management decisions can also be made using this information to ensure that our most valuable resource is being used efficiently and effectively.

# **Well Decommissioning Cost-share**

An abandoned water well can pose a serious safety concern if not properly sealed. Since all water wells provide a path from the surface directly to an aquifer, unused wells can allow pollutants to enter our groundwater. The Lower Big

Blue Natural Resources District (LBBNRD) has cost-share available to landowners who have an unused well to decommission. The Lower Big Blue NRD will provide cost share in the amount of 60% of the actual cost to decommission a well, up to \$500 (this does not include the cost of pump or tower removal.) In order to be eligible for cost share, the well must be decommissioned by a licensed well driller or pump installer. Applicants will need to submit the well decommissioning form which is available from our office or on our website. In addition, original receipts, W-9 and a copy of the Notice of Water Well Decommissioning as submitted to the Nebraska Department of Natural Resources is required. Cost-share is available on a first-come, first-served basis.



## **Watershed Dams**

276 dams and grade stabilization structures are strategically placed throughout the district. Most of these structures are on private property, however, the NRD holds a permanent maintenance easement with these landowners, this means that NRD staff have access to the site for inspection and maintenance. NRD staff inspects dams on an annual basis, however, we ask landowners to help us identify maintenance needs. If you have an NRD structure on your property, please take note of any trees, debris on trash racks or around tubes, rodent holes, or evidence of beaver activity. All of these things can affect the functionality of the structure. If you see any of these, please contact the office so we can conduct an inspection and address any issues.

## **NDEE Beachwatch**

#### What is Beachwatch?

Every summer, from May through September, officials with the Nebraska Department of Environment and Energy sample the water at 51 recreation areas across the state. They are testing for blue-green algal blooms and high levels of bacteria which can pose health risk to swimmers. Tests are conducted on a weekly basis. Typically, tests are conducted on Monday with online results available on Fridays. Within the Lower Big Blue NRD, beaches at Rockford Lake, Big Indian Recreation Area and Willard L. 
#### How we Respond:

If a high concentration is found, the lake will be placed on mandatory health alert until tests register acceptable levels for two consecutive weeks. During this time, swimming beaches are closed and full body contact with the water is not advised.

#### What to Watch For:

- Water that has a neon green, pea green, blue-green or reddish-brown color.
- Water that has a bad odor.
- Foam, scum or a thick paint-like appearance on the water surface.
- Green or blue-green streaks on the surface.
- Areas with algae that look like grass clippings floating in the water.

#### What To Do:





as soon as possible. Special attention should be paid to young children as they are more apt to swallow water during swimming activities. Additionally, they often take in a greater percentage of water than adults. Symptoms of skin exposure can include a rash or other skin irritation. Symptoms of ingestion can include headaches, nausea, vomiting and diarrhea. If any of these symptoms occur, contact your physician for treatment advice.
