

### **Occupation Tax Exemption—Chemigation Permits—Pooling**

### June 1st Deadline

<u>Chemigation Permits</u>—The chemigation permit renewal fee is \$25. After June 1st they will be considered a new permit and will be charged \$75. Also, check the expiration date for your applicator's license located on the right side of the permit. If it says, 2024, your license has expired. If you don't have a current license, you will be charged the new permit fee. All irrigated fields that utilize chemigation are required to have a permit. <u>Occupation Tax Exemption Form</u>—The Lower Republican NRD Occupation Tax Exempt form needs to be completed if you do not plan to irrigate part or all of your certified irrigated acres in 2024. **New this year**, if your certified irrigated acres are enrolled in a government program, i.e. EQIP, CREP, etc., these acres will automatically be exempted. If you do not have certified irrigated acres or you plan to irrigate all of your certified irrigated acres in 2024, you <u>do not</u> need to complete the Occupation Tax Exemption form.

<u>Pooling</u>—Pooling arrangements must be completed by June 1st for the 2024 irrigation season. Existing arrangements will continue unless written cancellation is received by the June 1st deadline. ## **Rural Water Superintendent**

The Lower Republican Natural Resources District is accepting applications for the Full-Time position of Rural Water Superintendent. Job responsibilities include but are not limited to the following: Perform routine maintenance on a public water supply system, reading meters, installing new hook ups, taking water samples, pump station and water tower maintenance, and being on call to respond to emergency situations. Must have a current valid driver's license in Nebraska. Must either have or be willing to obtain a Grade 4 water operator license. A company pick-up will be provided for work use. Applications may be obtained by calling the District office at 308-928-2182 or on our website www.Irnrd.org. Applications should be mailed to the District office located at 30 North John Street, PO Box 618, Alma, NE 68920 and must be received at the District office no later than the close of business on Wednesday, May 15, 2024.

## **Compact Call Year in 2024**

2024 has been designated as a Compact Call year. What does that mean? In the Lower Republican NRD there is a hard cap set at 13 inches for all ground water irrigated acres. There will be penalties for anyone pumping over the 13 inch hard cap. 2024 is year two in the allocation period in the Lower Republican NRD. You should have received allocation sheets from our office showing your 2023-2027 total allocation.

Pooling your acres can be extremely helpful during Compact Call years. If you are not currently pooling your acres across your fields, you may want to contact the office and consider this option. You will need signatures from all parties, landowners and operators, that are connected with any acres in the pool. It is best to start early if you need to obtain several signatures. New or modified pooling applications are due by **June 1st** for the 2024 irrigation season.

## Adventure Camp About the Environment

Adventure Camp about the Environment, ACE Camp, is back! The Camp will be held June 23rd through the 26th at Kamp Kaleo near Burwell. We encourage middle school students interested in outdoors to sign up for this educational, action-packed camp. To qualify, students should have completed sixth or seventh grade in the 2023-2024 school year.

The 4 day adventure camp provides students an opportunity to dive into different hands-on activities with a natural resources focus. 


Fees and registration are \$235 per camper. Campers can complete online registration on our website Irnrd.org/what-wedo/programs or on the Adventure Camp about the Environ-

## **National Land Judging**

National Land Judging was held April 30—May 2, 2024 in El Reno, Oklahoma. Alma FFA had a team place third at the State competition and qualify for Nationals. Members of the team were Karsten Bradley, Nolan Pfeil, Isaiah Neal and Wyatt Isaacson.

During land judging, contestants evaluate the soil's thickness, texture, and particle size. They look at the slope of the land and determine the possible erosion and flooding potential. They classify the soil based on those and many other factors.

## **Telemetry Flow Meter Project**

The Lower Republican NRD is moving forward with Phase 1 of installing telemetry enabled flow meters across the district and have already installed approximately 400 of the new meters. This first phase is targeting the Rapid Response Area wells and then subsequent phases of the project will expand to those meters outside of that area.

The District has contracted directly with McCrometer to install and implement these meters according to specifications. If a system needs additional pipe work or a check valve needs to be installed, the District will be asking those producers



to get that work done before installing the new meter. These modifications to the pipe or other parts of the system are required for compliance with our current rules and regulations so they will be at the expense of the landowner or irrigation system owner. The new meters do not have installation requirements beyond the current mechanical meters, so if the system is currently "in spec" it should not need to have any additional modification. We ask you to evaluate your current systems and if there is a possibility of replacing 2 meters with 1 telemetry meter, please contact us so we can review your setup.

Also, we would like to ensure the old mechanical meters are either returned to the proper owner or we can dispose of them if they are at the end of their useful life or will not otherwise be used. These meters were specifically calibrated to the pipe on the system. Using them on other systems or allowing someone else to use them may

result in improper usage readings and possible non-compliance with the rules and regulations.
