UPDATED RECREATION AREA RULES AND REGULATIONS

Galen Wittrock, Assistant Manager at South Platte Natural Resources District (SPNRD), manages the recreation areas within the District. At the January Board of Directors meeting, Wittrock proposed new changes to the existing Recreation Area Rules and Regulations handbook. The recreation areas that are located in the SPNRD are Goldenrod Wildlife Management Area near Chappell, Oliver Reservoir Recreation Area near Kimball and Goldeneye State Management Area, near Big Springs. The prominent changes in the handbook include, but are not limited to the following:

- No target shooting allowed at Oliver Reservoir
- Defining the hunting season to coincide with the federal and state hunting seasons
- All campers must register their campers and vehicles
- Open fires must only be contained in the designated, NRD provided fire pits

WELL DECOMMISSIONS

The SPNRD offers 65% cost-share up to \$600.00 for the proper well decommissioning of old irrigation, livestock, and domestic wells. Cost-share does not include the costs associated with pulling the pump or casing. We currently have budgeted \$5,000.00 for cost share assistance on well decommissionings.

SPNRD NITRATE LEVELS

The Sidney Ground Water Quality Management Subarea (SGWQMSA) is currently in phase II but has been proposed to move to phase III in the updated Districtwide Ground Water Management Area Rules and Regulations. When nitrates enter the groundwater system, it affects the health of the water over time. Due to the Brule Formation, the nitrates in that area soak into the ground easily. The SGWQMSA has exceeded 9.5 ppm as an average the past three years. Chris Kaiser, Natural Resources Coordinator points out that after reviewing the nitrate levels in different subareas in the District, the data that is most important to remember is the trend line in each subarea over the past 10 years. EVERGREEN TREE ENVIRONMENTAL DAMAGE

If you have any pine trees located on your property, you may start to notice damage toward the tops of the tree. The damage to these trees is due to environmental damage caused by the recent weather patterns. The type of damage you may notice will look similar to the image on the right. The tops of the trees will display a rusty color in the needles and there will be a visible contrast between the rust color needles and the live green needles. This damage is caused by harsh environments, such as dry conditions and the large temperature changes from last year. The damage is more likely to be noticed on non-native pines, such as Austrian pines, that are not as used to these harsh conditions. To prevent further damage from drought, utilize supplemental watering. For further questions, please contact the SPNRD.




KIDS CORNER
