# HAZARD MITIGATION PLAN UPDATE

Every five years the TPNRD is required to update the TPNRD Hazard Mitigation Plan for the communities and counties in the Twin Platte District, including Lincoln, McPherson, Arthur, and Keith Counties. A current Hazard Mitigation Plan is required for federal funding assistance from the Federal Emergency Management Agency (FEMA) in the event of a natural disaster. Since 2007, Nebraska and FEMA have required that a Hazard Mitigation Plan be developed within NRD boundaries. TPNRD received a grant from FEMA to update the plan. The TPNRD will be working with communities and counties within the district, and JEO Consulting Firm, to carefully piece this updated plan together which is to be completed by April 2021. There will be public meetings throughout the process of updating the plan, where the public can bring any concerns or ideas. The public will be invited to attend the kick-off meetings beginning March 2020. The dates and location of the meetings will be posted in the newspaper and on the TPNRD website and Facebook page.

# NRCS: Alternative to Cedar Tree Windbreaks

Shelter for livestock can influence the success of calving in a livestock operation. Protection from the wind and snow is not always readily available from natural topography or living windbreaks. A livestock shelter structure is a windbreak constructed in a "V" configuration that will create protection from snow and minimize snow in the crux of the "V." The sides of the "V" should form a 90-degree angle and the point should be built facing into the prevailing winter winds. This will cause snow to be diverted around the ends of the barrier and form drifts away from the

sheltered area. A livestock shelter structure is an alternative to planting living shelterbelts that consist of eastern red cedar. The Twin Platte Natural Resources District no longer provides financial assistance for planting eastern red cedar because of encroachment on native rangeland. Installing a windbreak needs to come with the end goal in mind. Contact your local USDA Natural Resources Conservation Service office for technical and financial assistance.

# TPNRD 2019 CONSERVATION AWARDS

### Jensen Ranch: Tree Planting Award

Jensen Ranch has a long history of excellence in conservation, having planted over 2,800 trees in the past 16 years. The planting of trees as windbreaks in the sandhills serve many purposes and have endless benefits to the land as well as the livestock. The ranch operation currently covers 10,360 acres in Arthur and Grant Counties. The first tree planting was done in the 60's, but came with many complications as there was no weed barrier when the trees were planted. This site was not accessible to water and seemed to take forever for the trees to grow into a usable protection for the livestock. The annual replant program finally re-established and is now a very impressive windbreak that works efficiently. Since then, the Jensen's have designed and planted four more plantings with the weed barrier and the success rate has greatly improved. The protection that these windbreaks provide and the wildlife that inhabits them have made the efforts very much worthwhile.

### Star Cattle Company Co. were plar Grassland Conservation Award

Over the years the Star's have been able to slowly expand their operation and diversify with fertile Platte Valley farmland and lush hay meadows. They have utilized the North Platte River accretion grounds and tree groves for calving cows and backgrounding calves. As a company they have also invested in productive pastures as opportunities arose. One of the most beneficial and beautiful pastures has been the ground along the Birdwood Creek. Range management is always a priority for the operation, never wanting to overgraze the highly utilized areas. The goal is always keeping the grasslands healthy for years to come. Working with the USDA-NRCS on EQIP projects allowed Star Cattle Company to implement rotational grazing on each of its ranges in the last six years. To help increase efficiency, water lines were dug, numerous tanks installed, additional wells drilled, as well as many fence lines adjusted as needed. This would not have been attainable in such a short time frame without their assistance.
