

## **Eastern Red Cedar Control Demonstration Coming Soon**

An Eastern Red Cedar control demonstration is being planned for this spring in the Upper Loup Natural Resources District. The day will start with a short presentation which will discuss the economic impact of Eastern Red Cedar encroachment in addition to local Cost Share Programs available. The demonstration will directly follow the presentation. Several local tree removal contractors are to be invited. Be sure to check your local newspapers for upcoming information about the demonstration.



## **Tree Orders for Spring**

The Upper Loup Natural Resources District continues to sell and plant trees to property owners across the district as it has for the past 40+ years. Anyone wishing to plant trees in the spring should be making plans now. The Upper Loup NRD cost-shares on hand plant orders of at least 100 trees or shrubs and machine planted trees or shrubs of at least 200 trees.

Early planning and tree ordering is encouraged for cost share funds, as they are distributed on a first come, first serve basis. The



benefits of windbreaks are numerous. They protect your home and livestock, and when planted along crop land edges they increase crop production. Call Shane at our office and he will assist you with deciding which tree species will work best for you, draft planting plans, and assist in filling out the cost-share forms. The order deadline for trees and shrubs is February 1, 2020.

## Drought Mitigation Plan to be Developed

Drought will always be a nemesis for both ranchers and farmers. Management flexibility and pre-drought planning are critical for creating resiliency. The NRD will soon begin a District wide drought plan. The intent is to define drought locally and to identify processes and strategies in order to prepare for, respond to, recover from and manage the impacts of future drought events. The plan will be a tool that will assist the NRD in long term resource management and policy development. The NRD will be putting together a stake holder group to provide recommendations for the District. If you would like to be included in this group please contact our office (308-645-2250) by February 1, 2020. Being apart of the planning process will not be a huge time commitment, approximately 2-4 hours over the project time line.

The NRD is excited to share that we were approved for a Nebraska Environmental and Energy Waste Reduction Grant to purchase a recycling trailer for the Village of Purdum and surrounding area. The recycling trailer is located at the intersection of Purdum Ave and W North Loup Rd-the Harsh Mercantile lot. The types of recyclables accepted include cardboard, paper, tin, aluminum, and 1 & 2 plastics.
