# NRD Recreation Exploration Program Explanation and Terms & Conditions

The NRD Recreation Exploration challenges participants to visit as many Natural Resources District (NRD) recreation areas as they can between March 1, 2023, and September 15, 2023. The goal of the NRD Recreation Exploration is to promote the more than 80 NRD recreation areas across the state and encourage individuals to get outdoors and explore nature.

## **How It Works:**

Participants may visit any NRD recreation area and submit an online form, making them eligible to be entered into random drawings for prizes based on the number of locations visited. All eligible entries will also be included for selection of a Grand Prize and Runner-up prizes.

### Each submission form should include:

- First and Last Name
- Valid email address
- Valid mailing address
- Valid phone number
- Date of Trip
- Location Visited
- NRD Visited
- Brief description of the visit
- Photo submission with the recreation sign or recognizable landmark (Once uploaded, these
  photos will become the property of the Nebraska Association of Resources Districts. Any
  photos, names, or information submitted can be shared with local NRD for newsletter list,
  social media, and website use.)

#### Prizes:

- Monthly prizes are selected from eligible participants by monthly drawings from March through September. To be eligible for monthly drawings, submissions must be made no later than Sept. 15, 2023.
- Annual Grand Prize winners, along with Runner-up and Second Runner-up winners, will be selected from eligible participates in late September. To be eligible for the Annual Grand and Runner-Up prizes, submissions must be made no later than Sept. 15, 2023.
- The Grand Prize winner will be selected based on the highest number of NRD recreation areas visited, as recorded from the online forms. Runner-up and Second Runner-up winners shall also be selected based on the next highest number of NRD recreation areas visited. In the event of a tie for the Grand, Runner-up, or Second Runner-up winners, the winner for each category of prize will be randomly selected from the pool of the tied entrants.

• Prizes won in this program may not be returned to the providing retailer or organization for cash or credit. Larger prizes will be required to be picked up from a location to be determined during the prize-pick-up period.

# **Participation And Cost:**

Participation in the NRD Recreation Exploration is open to everyone.\* It is a free program to familiarize people with Nebraska's NRD recreation areas. While most NRD recreation areas are open to the public at no charge, some require an entry permit. Participation in the Program does not exempt participants from first obtaining a required entry permit. Some of the NRD recreation areas requiring permits include but are not limited to:

- Iron Horse Trail (Nemaha NRD Permit)
- Kirkman's Cove Recreation Area (Nemaha NRD Permit)
- Duck Creek Recreation Area (Nemaha NRD Permit)
- Lake Wanahoo Recreation Area (Lower Platte North NRD Permit)
- Willow Creek Recreation Area (Nebraska Game & Parks Commission Permit)
- Enders Reservoir State Recreation Area (Nebraska Game & Parks Commission Permit)
- Danish Alps State Recreation Area (Nebraska Game & Parks Commission Permit)

#### **Rules:**

Winners will be notified by email or telephone and announced on social media and with a press release. By participating in the Program, all winners agree that their identity may be disclosed in any social media or press release announcement.

Adherence to the NRD Recreation Exploration rules will be checked against prize winners. Winners must be in good standing with Nebraska's Natural Resources Districts.

By entering or participating in the Program, participants agree to be bound by these Official Terms and Conditions, and by the decisions of NRD sponsor, which are final and binding in all respects.

Program participants assume all liability for any injury, death, or damage caused, or allegedly caused, by participating in the Program or use or redemption of any prize.

\*NRD staff and Directors, and their immediate families are not eligible to win prizes.
