

New Phase III Rules and Regulations take Effect February 1, 2019



At the December 17, 2018 Board of Directors Meeting the Directors voted 7-5 to pass the Phase III Controls and designating the Phase III area in the district. The controls will be effective starting February 1, 2019. A summary of the controls is as follows:

- 1. The controls establish a Phase III Groundwater Quality Management Area (see map)
- 2. The controls are limited to the controls in Phase III Groundwater Quality Management Areas.
- 3. The controls authorize randomized soil sampling on lands located within Phase III areas to determine residual nitrate-nitrogen levels. The soil samples will be collected in the fall from fields that have been harvested. Depending on the levels of nitrate-nitrogen collected from the samples, future management in the application of nitrate-nitrogen may be required along with meetings with District staff and board.
- 4. The controls authorize the District to issue orders to cease the application of nitrogen, cease irrigation, reduce or remove certified irrigated acres and such other measures as authorized by law for persons who fail to attain the necessary nitrate-nitrogen levels after 3 years.
- 5. The controls repeal prior Phase III rules regarding Fertility, Pest, and Irrigation Management Plans.

NRD Finalizes New Water Plan for Integrated Management

The Upper Elkhorn NRD has finalized their Voluntary Integrated Management Plan (V-V-IMP) with the Nebraska Department of Natural Resources (NeD-NR) to jointly manage surface and groundwater. The V-V-IMP has been a year in the making and should be voted into action at the December 17, 2018 Board Meeting. If approved, this new water plan will become effective February 1, 2019.

Every NRD in Nebraska has worked with the NeD-NR to create an V-V-IMP for their District to manage water uses and water demands. The ultimate goal of the V-V-IMP is to protect current water users while allowing for economic growth and well-being across the District. The V-V-IMP assesses how much water is available, how much water is being used, and how much water could be developed in the future. As part of the planning process, UENRD and NeDNR hosted a Stakeholder Advisory Committee made up of irrigators, municipalities, and other persons interested in water management. Stakeholders played a crucial role in providing input on goals, objectives, and action items, as well as provided questions, concerns, and discussion. The Stakeholder Advisory Committee met three times between May and August, and a formal Public Hearing was held in November.

The V-IMP has four goals: 1) Understand water supplies and water uses within the District, by collecting data (static water levels, water use reporting, stream gauges, etc.), and evaluating variability in water supplies. 2) Prevent or mitigate water related conflicts within the District, by assessing V-IMPacts on current water users and by maintaining rules and regulations to enhance water management. 3) Plan for sustainable growth in water uses and demands, by determining sustainable use and evaluating new ways to V-IMProve water supplies. 4) Inform the public of the District's water resources and efforts, by use of educational materials and public outreach.

Upper Elkhorn NRD Board of Directors Decreases Property Tax Asking for FY 18-19

NRD Board of Directors in September approved the 2018-2019 fiscal year budget with a decrease in the mill-levy and property tax asking. The FY 18-19 budget request is only 1.54 cents per \$100 of valuation for a total of \$755,985 in property tax asking. A decrease of \$6,120 from fiscal year 319 Grants.

The V-IMP also has two groundwater controls and four surface water controls to meet the goals of the water plan. Groundwater Controls: 1) Certification of groundwater irrigated acres; and 2) Establish a limit on the expansion of groundwater irrigated acres. Surface Water Controls: 1) Restriction on addition of surface water irrigated acres in the Lower Niobrara Basin. 2) Education requirements for new surface water users in the Upper Missouri Tributaries Basin. 3) Limitation on expansion of surface water irrigation in the Lower Platte Basin. 4) Temporary stay on development of surface water irrigation in the Middle Niobrara Basin.

Get Your Groundwater Irrigated Acres Certified

The Upper Elkhorn continues Groundwater Irrigated Acre Certification. One of the goals of certifying irrigated acres, is to have all acres certified within 2 years after the effective date of the V-IMP. This plan becomes effective February 1, 2019.

Lower Niobrara River Basin: Landowners who own groundwater irrigated acres within the Lower Niobrara River Basin and can show proof that they irrigated them at least once between the years 2003 and October 16. 2007 will be able to certify their acres at 100%. Acres irrigated prior to 2003 will be considered Historically irrigated and with the proper documentation will be certified at 95%.

Lower Platte River Basin: Landowners who own groundwater irrigated acres within the Lower Platte River Basin and can show proof that they irrigated them at least once between the years 2004 and December 16. 2008 will be able to certify their acres at 100%. Acres irrigated prior to 2004 will be considered Historically irrigated and with the proper documentation will be certified at 95%.

Outside Area the 10/50 Line (Northern Antelope County): Landowners who own groundwater irrigated acres within the area outside the 10/50 line and can show proof that they irrigated them at least once between the vears 2008 and October 1, 2012 will be able to certify their acres at 100%. Acres irrigated prior to 2008 will be considered Historically irrigated and with the proper documentation will be certified at 95%.

Historically irrigated acres: Historically irrigated acres shall consist of groundwater irrigated acres which were irrigated prior to 2003 for the Lower Niobrara River Basin. 2004 for the Lower Platte River Basin and 2008 for the area outside the

10/50 line or are currently enrolled in the Conservation Reserve Program, Conservation Reserve Enhancement Program, Environmental Quality Incentive Program or other federal, state or local conservation program must also be certified if there is any possibility of future irrigation.

Documentation Acre Certification: Proper documentation for the certification of irrigated acres will include either county assessor records noting the year and irrigated acres or an FSA 578 form. Any irrigated acres that are not certified during the specified dates would not be allowed to have groundwater applied to them for any purpose. Final acre certification will be based off of County Assessor and/ or FSA records.

If Groundwater Irrigated Acres are not certified with the Upper Elkhorn NRD. there is a chance that they will not be allowed to be irrigated in

issues over the past few vears, a number of trees have been removed to develop areas for crop production. The Upper Elkhorn NRD would like to encourage all those landowners who removed trees to consider replacing them this upcoming spring.

There are several incentive programs to help offset the cost of installing a new windbreak on the federal, state and local level. Contact your local Natural Resources Conservation Service or your local NRD to find out what programs are two practices to help available.

The Upper Elkhorn NRD will be taking orders from now until March 1st. Trees are available on a first come first serve basis and are available

consisting of conifers, broadleaves and shrubs. Hand plant trees should be ordered in bundles of 25 while machine plant orders will be based on the windbreak design. The NRD can also provide technical assistance to cooperators who would like help designing a new windbreak or renovating an old one. The technician will suggest the type of trees best suited for your soil type and design a layout beneficial to your needs.

The NRD also offers increase the survival rate of new seedlings, drip irrigation and conservation weed mulch. Drip irrigation is available for cooperator installation and is used when there

Due to a number of in a variety of species is a water source at the site. Conservation weed mulch is installed over the seedlings to help control weeds and retain moisture. Both practices can be very beneficial to young windbreaks and should be considered when placing vour order.

> Remember, the Upper Elkhorn NRD is also your one-stop shop to order trees and weed mulch. The NRD can plant and install the trees and fabric as we have for the past 40+ years. Trees and mulch purchased from the Upper Elkhorn NRD could be eligible for local or state funds. Bazile Groundwater Management Area Update


This past spring the BGMA Group sent out a survey to landowners and operators in the BGMA. The purpose of the survey was to get a better understanding of the current management and beliefs in the BGMA. 900 surveys were sent out and 271 were returned (32%); 98 from landowners and 173 from operators. Some of the findings of the survey were:

- •About half, 52%, of operators have confidence in the UNL Algorithm for calculating recommended nitrogen fertilizer application rates. 31% of operators said they are not familiar with the algorithm.
- •Of the 74% of operators who would like to improve their nitrogen fertilizer efficiency, the most commonly indicated interests were in employing variable rate application, nitrogen stabilizers, slow release nitrogen, and nitrogen inhibitors.
- •51% of operators DO NOT plant cover crops.
- •Of the operators that plant cover crops, 76% plant single species and 24% plant multi species.
- •57% of operators in the BGMA manage some livestock in their operations.

The BGMA Group also held a meeting with the crop consultants and fertilizer dealers who work in the BGMA on October 30, 2018. The purpose of this meeting was to get the crop consultants, fertilizer dealers, and the agencies involved in the BGMA in the same room and have a discussion about nitrogen management. About 15 crop consultants and fertilizer dealers attended.

The crop consultants and fertilizer dealers indicated there is probably about 40% of operators they don't work with, which correlates with data gathered in the survey. They feel these operators may or may not be managing nitrogen as well as the operators they do work with. When asked how to get operators to better manage their nitrogen some crop consultants and fertilizer dealers said one way is to regulate nitrogen more. Good conversation also took place on macro & micro nutrients which can make nitrogen uptake more available to the plant.

UENRD Approves New Irrigated Acre Expansion for 2019 Growing Season

The Upper Elkhorn NRD held an expansion of groundwater irrigated aces during the month of October. The Board of Directors had voted back in July to allow up to 1000 new groundwater irrigated acres for the 2019 growing season. During the month of October, applications seventeen were received ranging from 2 acres to 136 acres in Antelope County. The applications were ranked on various water quality and quantity criteria; the amount of acres to be expanded; soil classifications; location; establishing conservation practices; incorporating best management practices; and, whether or not the applicant was complying

with the UENRD Groundwater Management Plan Rules and Regulations. The UENRD Board of Director voted November 26, 2018 to approve the expansion of 793 groundwater irrigated acres for the 2019 growing sea-These new acres will have to be developed and irrigated prior to October 1, 2019. new irrigated acres must also be certified following the 2019 growing season with documentation from either the FSA or County Assessor. The UENRD will continue to monitor the water resources of the district to determine if the expansion of groundwater irrigated acres will continue or be suspended in the future.

UENRD Offers Scholarships to High School Seniors

Each year, the Upper Elkhorn Natural Resources District offers three \$500 scholarships to graduating High School Seniors from the District. These scholarships are available for students who are planning to further their education in a field related to natural resources or agriculture. Attention Landowners-Soil Sampling Requirement!

Upper Elkhorn Natural Resources Groundwater Management Plan: Phase II Requirement

Reminder to everyone in the UENRD Phase II areas – Deep soil sampling analysis (mandatory two foot sample) for nitrate-nitrogen content applies to each field going into corn, larger than 40 acres, with more than 50 pounds per acre of actual nitrogen fertilizer applies. This soil sampling information is required on your Phase II report at the end of the 2018 growing season to be submitted to UENRD.
